# DETERMINATION AND FINDINGS FOR SOLE SOURCE PROCUREMENT

### 1. <u>Authorization<sup>i</sup></u>

## 2. <u>Minimum Need</u>:

The Office of the People's Counsel (OPC) proposes to procure the services of DataNet Systems Corporation for the purposes of OPC website maintenance.

#### 4. <u>Facts That Justify a Sole Source Procurement:</u>

- A. The Office of the People's Counsel "OPC" is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. DataNet Systems Corporation is a Certified Business Enterprise technical services company with headquarters in Washington, DC providing quality technical and management solutions for commercial and government webbased application systems and software integration for communications and networking applications. In addition, DataNet Systems Corporation is on the DC Office of Contracting and Procurement's DC Supply Schedule
- C. DataNet Systems Corporation developed OPC's current website and has provided website maintenance service since its inception and has experience and knowledge of OPC's website infrastructure and website processes and procedures.
- D. Due to DataNet Systems Corporation's prior work with OPC in connection with its website development and maintenance; it's Certified Business Enterprise status; and its DC Supply Schedule status; it is recommended that a sole source contract be awarded to DataNet Systems Corporation.
